WEST BENGAL STATE SCHOLARSHIPS FOR MINORITY STUDENTS (Funded by West Bengal Minorities' Development & Finance Corporation)

To address the growing aspiration for education in the minority communities of the state and with a view to providing them more avenues for socio-economic and educational mobility by extending financial support and encouragement to the meritorious students belonging to the minority communities, the State Government has decided to set up the "Aikyashree" West Bengal State Scholarships for Minority Students in West Bengal.

Objective	The objective of the scheme is to provide/supplement financial assistance to the student's parents.
Eligibility	<ul style="list-style-type: none">Students domiciled in West Bengal and pursuing post-matric levels in the regular course are eligible.Institute must also be located in West Bengal.Students should pass in the year 2022 or 2021 (unable to get admission in the year 2021 due to unavoidable reason) with at least 53% marks in aggregate in Graduation (Honours Subject) from any State University for Post Graduate Level Scholarship (General Education).Annual family income should not exceed Rs.2.5 lakhs (Income certificate to be issued by any Gazetted Officer).Post-Graduation courses – 53% in the honours subject.For renewal of scholarship, application must be submitted online to the concerned scholarship sanctioning authority after admission in his/her higher class due to promotion by passing in the first attempt. In case of Semester mode-all semester examinations/papers need to be cleared in the first attempt.

“SWAMI VIVEKANANDA MERIT CUM MEANS SCHOLARSHIP” (Funded by the Department of Higher Education)

With a view to assisting the meritorious students belonging to economically backward families in the State of West Bengal to pursue higher studies, the Government of West Bengal introduces this scheme of giving scholarships at different levels of higher studies, at educational institutions based in West Bengal.

SCOPE:

- The scheme benefits Post Graduate level students pursuing Science/Arts/Commerce. These scholarships will be sanctioned to deserving students on merit-cum-means criteria.
- **Candidates opting for these scholarships and found eligible, will not be allowed to enjoy any other governmental (central/state) scholarship or stipend for the same course/stage of study. However, one time grants or assistances received from any source, or free or partly-free studentship allowed by the host institutions will not debar the students from availing of the benefits of this scheme.**

DIFFERENT TYPES OF STATE SCHOLARSHIP FOR THE POST GRADUATE STUDENTS

“OASIS SCHOLARSHIP 2022-2023”

(Funded by Backward Classes Welfare Department and Tribal Development Department)

OASIS stands for Online Application for Scholarships in Studies and is the online portal where students belonging to reserved categories can apply for financial assistance. This website particularly highlights scholarships and their application procedures. The portal is open to track the progress of the application and view schemes. But, the schemes in the portal are especially for students of the backward classes, scheduled tribes, and casts. They can easily apply for financial assistance based on their educational qualifications. The main benefit of OASIS is that they will not have to go through complicated offline procedures and will have to apply online.

OASIS Scholarship Aim:

The chief objective of launching the OASIS portal was to ensure that every eligible student can apply for government-funded scholarships. Earlier, students had to apply in government offices for these scholarships and the procedure was time-consuming. With the introduction of the portal, they can easily apply for suitable financial assistance based on their qualification. This process will be hassle-free and will save time and money. Moreover, students will be able to get financial assistance at their doorsteps.

The following students are eligible to apply on the portal:

1. Student must be a resident of West Bengal.
2. Must have all the documents required at the time of registration.
3. For Post Matric Scholarships, a post secondary or matriculation student of *Scheduled Caste or Tribe* is eligible to apply if the total income of the family is less than Rs. 2.5 lakhs per annum from all the sources.
4. For Post Matric Scholarships for a student belonging to *Other Backward Classes*, the student must be in either post secondary or post matriculation and the combined family income must be less than Rs. 1 Lakh per annum.

WB oasis Post Matric Scholarship:

Post Matric Scholarship to OBCs: The objective of this Scheme is to provide financial assistance to O.B.C. students studying at Post-secondary stages of education to enable them to complete their education. This scheme has been implemented in this state from the financial year 2003-04. The scholarship is given for study of various recognized Post secondary courses pursued in recognized educational institutions. Same procedure for payment of Post-matric scholarship to SC/ST student is followed. There is a ceiling of family income of Rs.1 Lakh per year. The amount of scholarship admissible for each group has also been indicated below:

Post Matric Scholarship to SC/ST: The objective of the scheme is to provide financial assistance to the Scheduled Castes and Scheduled Tribe students studying at post matriculation or post secondary stages to enable them to complete their education. The Income ceiling of parents/guardian has recently been enhanced from Rs. 2 Lakh to Rs. 2.5 Lakh per year. The amount of scholarship admissible has also been indicated below. Tuition fees and compulsory nonrefundable fees are also paid as per approved rate of the Govt. institution.
