CIRCULAR

In pursuance to the direction given by His Lordship Hon'ble Justice Subrata Talukdar, of the Hon'ble Calcutta High Court by an order dated 16.01.2017 in W.P. No. 543 (W) of 2017 and W.P. No. 546 (W) of 2017 the authorised representative of (a) Vidyasagar Teachers' Training College, situated at Village- Sagardighi, PO. Kamlabari, District- Malda, West Bengal – 732103 and (b) Vivekananda Teachers' Training College, situated at Village- Chandipur, PO. Kazigram, PS. English Bazar, District- Malda, West Bengal – 732103 respectively called upon to produce the proper and clear explanation on the issued letter vide 49/B.Ed/UGB/CE-17 dated 10.02.2017 along with required documents on 22.02.2017 at 12 noon at the Meeting Room of the Hon'ble Vice Chancellor, University of Gour Banga, Malda.

After the hearing, the authority of the University of Gour Banga, Malda decided that further scope for affiliation under University of Gour Banga, Malda would stand cancelled in favour of Vidyasagar Teachers' Training College and Vivekananda Teachers' Training College.

Accordingly, the authority also took the following resolution so that the admitted students can pursue their course of study without any interruption:

1. The students of the 1ST & 3rd Semesters for the year 2017 of study of the said colleges shall continue their remaining activities of course study under a Nodal Centre directly supervised by the University of Gour Banga, Malda. The University of Gour Banga, Malda shall take responsibility of the examinations related and other academic activities of the said students until completion of the course.

The resolution has also been appropriately communicated to The Regional Director, ERC- NCTE, Bhubaneswar vide Ref. No. 70/B.Ed/UGB/EC-17 dated 27.02.2017.
